7. Election of the Faculty Senate Executive Committee

8. Election of 2 faculty members for the Interim College Council Executive Committee

The Interim College Council Executive Committee (ECCC) meets once in September to set the agenda of the September meeting of the College Council and is in operation from July 1 until that time. The Interim ECCC is also empowered to do the work of the ECCC during the summer

if such work is needed. The Senate President and the Senate Vice President are statutory members; two additional Senate/College Council members must be elected at today's meeting.

The Senate elected Ned Benton and Francis Sheehan.

9. Election of Senate representatives to the College Budget Planning Committee, Fiscal Planning Subcommittee, and Strategic Planning Subcommittee

Because the budget allocation from NYS arrives at CUNY and then at the campuses during the summer and decisions must be made about the budget during the summer, the Senate always elects its budget representatives at this first organizational meeting. The Senate President and Vice President are statutory members. The Senate elected Fritz Umbach and Tom Kucharski to the Fiscal Advisory Committee and to the College Budget Committee and elected Fritz Umbach and Janice Dunham to the Strategic Planning Committee.

10. Election of 5 faculty members to the Search Committee for Associate Provost & Dean of Undergraduate Studies

By secret, written ballot the Senate elected:

Professor Lisandro Perez (LA/LAS) will chair the committee. The other members are Interim Dean of Undergraduate Studies Allison Pease; Dean of Graduate Studies Anne Lopes; Associate Provost for Institutional Effectiveness James Llana; Dean of Students Ken Holmes; and an undergraduate student.

11. Proposed statement on faculty teaching load mitigation for adoption by the Senate

For the new Senators, a review was provided about the teaching load mitigation proposal from the Faculty Senate, its goals, its current status, and the positions taken to date by the Council of Chairs which has jointly adopted various statements with the Faculty Senate.

The most recent statement was developed by a group of Chairs and Senators and PSC leaders and was adopted last week by the Council of Chairs and is before the Faculty Senate for adoption by it; this statement contains the language that the elected faculty leadership want

included in John Jay's Financial Plan for 2014-15, which is due at the CUNY Central Office by early September:

Within the Adjunct budget, the \$120,000 allotted to faculty reassignments for workload mitigation in FY 2013-2014 is increased to \$240,000. The additional funds will be used to extend and streamline the Provost's "Revitalization of Teaching" program, in consultation with elected faculty leaders, so as to enhance teaching by facilitating a sustainable workload.

We urge the Faculty Senate, Council of Chairs, and the PSC, and the faculty members of the Financial Planning (FPS) and Strategic Planning (SPS) Subcommittees, and the College Budget Planning Committee (BPC) to take appropriate steps to support inclusion of this language in the FY 2014-2015 Financial Plan.

We urge the faculty members of the Budget Planning Committee (BPC) to individually endorse this language for inclusion in the Financial Plan and to vote for any motion or action at the BPC to achieve this result

The Senate unanimously adopted this statement by a vote of 39 yes, 0 no, 0 abstention.

The meeting was adjourned at 3:45 PM.
