# 2. Announcements & Reports

President Benton reviewed the status of the Economics Department adjunct who had tweeted that one benefit of teaching at John Jay is that he taught "future dead" police officers. When asked, Professor Jay Hamilton, the chair of the Department of Economics, said that he had been consulted after the adjunct had been placed on administrative leave, but that concern for the safety of the adjunct (and others), given anonymous threats that had been reportedly received required the administration to act swiftly.

- 3. Adoption of Minutes #468 of the September 5, 2017, Faculty Senate meeting. Approved.
- 4. Faculty Personnel Committee Statement on Faculty Service

President Benton reported that the Faculty Personnel Committee (FPC) has created an ad hoc advisory committee to advise it about faculty service, with a report due by December 1. This ad hoc committee will have 4 members chosen from among the FPC members and 3 chosen by the Faculty Senate. The four FPC members are: Jay Gates (English), Amy Green (ISD), Jose Morin (LLA), and John Pittman (Philosophy). Elected by the Faculty Senate were Ned Benton (Public Management) and Chevy Alford (SEEK). A third Senate member will be sought by the Executive Committee and recommended to the Senate for its approval at our next meeting. There was general consensus that it would be desirable to have at least one faculty member who has been recently awarded tenure and who could therefore knowledgeably speak to the issue of service by untenured faculty members.

President Benton reported that Interim Provost Anne Lopes has raised the question as to whether the metaphor of the stool with three legs (regarding teaching, research, and service) should perhaps be revised to a different metaphor, that of a thread made of three strands, because if all three legs of a stool are not precisely the same length the stool is unstable but a thread can be strong and viable with three strands of varying strengths or thicknesses.

# 5. First Review: "Faculty Senate Statement on Faculty Leadership and Engagement"

After discussing the draft statement on faculty leadership and engagement from the Faculty Senate Executive Committee and making suggestions for revisions, the Senate approved adopting the statement by unanimous vote. The Executive Committee will further revise the statement, based on the comments at today's meeting, and bring it back to the Senate at our next meeting for another vote after which it will be sent to the administration.
